

**TOWN OF BAYFIELD
WEIGHT LIMIT ORDINANCE
#99-01**

THIS ORDINANCE SUPERSEDES ALL OTHER ORDINANCES ENACTED BY THE TOWN OF BAYFIELD PERTAINING TO ROAD WEIGHT LIMITS. THE FOLLOWING WEIGHT LIMITS AND PROVISIONS SHALL BECOME EFFECTIVE UPON ADOPTION OF THIS ORDINANCE AND POSTING.

1. A five (5) ton gross weight limit shall take effect on all Town of Bayfield roads effective 12:01 a.m. on March 15 annually, and remain in effect until 11:59 p.m. May 15.

The following vehicles will be exempt:

- A. School buses (where picking up or dropping off persons residing on the highway being traveled).
- B. Emergency vehicles: where picking up or dropping off persons residing on the highway being traveled.
- C. Milk trucks: if picking up milk from farms in the Town of Bayfield on the highway being used.
- D. Town of Bayfield vehicles.
- E. Septic Service trucks: by permit only
- F. Fuel trucks by permit only.

2. A fifteen(15) ton gross weight limit shall take effect on the following roads from 12:01 a.m., May 16 annually, and remain in effect until 11:59 p.m. December 15.

- A. Valley Rd. entire length
- B. Star Route- entire length
- C. Weber Rd. from junction with Hatchery Rd. east on surfaced portion only.
- D. Hatchery Rd.- entire length
- E. Betzold Rd.- entire length
- F. Ski Hill Rd.- entire length
- G. Whitetail Rd.- Deerfield
- H. Lampa Rd. - entire length

The following vehicles will be exempt:

- A. School buses (where picking up or dropping off persons residing on the highway being traveled).
- B. Emergency vehicles: where picking up or dropping off persons residing on the highway being traveled.
- C. Milk trucks: if picking up milk from farms in the Town of Bayfield on the highway being used.
- D. Town of Bayfield vehicles.

All other vehicles exceeding the fifteen (15) ton gross limit shall be required to obtain a permit.

3. The following roads shall be classified as "Class B" roads and shall be subject to all regulations for such a classification.

- A. Hatchery Rd.
- B. Trailer Court Rd.
- C. Lakeshore Dr.
- D. Whitetail Ave.

Exemptions are the same as #1 above.

The weight limits established by this ordinance shall be imposed by posting signs on or along the roads to which they pertain, which give reasonable notice that weight limitations are in effect and the nature of the limitations.

The Town of Bayfield Board of Supervisors may change the above listed dates as weather conditions dictate. If a change is made, it will be published in the official town paper and posted on the bulletin board at the Town of Bayfield Town Hall.

Persons requesting a permit for vehicles to travel on posted roads shall contact the Town Chair. In the Town Chair's absence, the road foreman can be contacted. Formal restrictions as to route, time of day, number of trips, etc. may be included in the permit.
